RE: Compliance with the January 1, 2013 Narrowbanding Deadline

Dear Licensee:

The Federal Communications Commission's database shows that 1 of the Public Safety Pool authorizations for which you are licensee of record contain(s) an emission designator authorizing "wideband" operation with a channel bandwidth in excess of 12.5 kilohertz (kHz). See lead call sign WQFT873. While such wideband operation is currently permissible, this is a reminder that the **deadline** for converting to "narrowband" operation is quickly approaching. You must bring these facilities into compliance with the Commission's narrowbanding rules by **January 1, 2013**, either by migration to 12.5 kHz (or narrower) channel bandwidth or by utilization of technology that achieves equivalent efficiency. The Commission began implementing the narrowbanding rules over ten years ago and set January 1, 2013 as the deadline to give licensees ample time to comply. If you have not done so already, we urge you to take the necessary steps as soon as possible to ensure timely compliance with the January 1, 2013 deadline.

Timely completion of narrowbanding is important because it will ensure more efficient use of the spectrum, relieve congestion, and result in increased channel availability for land mobile radio systems. In addition, after the January 1, 2013 deadline, the Commission's rules will no longer protect unauthorized wideband operations from harmful interference, availability of wideband equipment will diminish or cease, and the Commission may license new narrowband facilities that overlap pre-2013 wideband channels. Unauthorized wideband operation after this date in violation of the Commission's rules may subject licensees to enforcement action, including monetary forfeitures or license revocation. If newly authorized facilities receive harmful interference from unauthorized wideband operations, the Commission may require the non-compliant wideband operator to promptly remedy the interference, which may include cessation of operations, if necessary.

The Commission has information resources available to assist you in the narrowbanding process. For further information regarding the narrowbanding rules, planning for the narrowbanding process, frequently asked questions, and links to technical and funding resources, please go to www.fcc.gov/narrowbanding. LAFAYETTE COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) HOUSING REHABILITATION/REPLACEMENT PROGRAM

ż

The Lafayette County Board of County Commissioners has received a CDBG grant to rehabilitate or replace a minimum of 10 owner-occupied primary residences in the <u>unincorporated</u> area of Lafayette County. The County will spend \$595,000 from the CDBG grant on the properties, and will also contribute \$120,000 in SHIP program funds, for a total of \$715,000 in direct assistance.

Homes may be either site-built or mobile homes constructed after 1995. Clear title to the property is required, although a mortgage on the property may exist if the balance is in line with the property value, and the owner has a good payment history. All property taxes and assessments must be current before the homeowner's application will be approved. The homeowner must demonstrate reasonable care of the property, including the yard.

Of the 10 households to be assisted, 2 must be in the income range of 30% of the area median income. Another 2 households must be in the income range of 50% of the area median income. The remaining 6 households may have incomes up to 80% of the area median income.

The financing will be in the form of a deferred payment loan to the owner. The term of the loan will be for five years for loans of less than \$25,000, seven years for \$25,000 to \$40,000, and ten years for loan of more than \$40,000.

The cost limit for rehabilitation will be limited to \$40 per square foot for site-built dwellings, not to exceed \$40,000. The cost limit for mobile or manufactured homes constructed in 1995 or later will be \$11 per square foot, not to exceed \$15,000.

The limit of CDBG financial assistance for replacement site-built housing is \$85 per square foot, up to \$80,000 per home. The limit of CDBG financial assistance for replacement of a mobile home with another mobile home is determined by the current cost of a comparably sized new replacement mobile home of high quality, plus associated costs of set-up, clearing the site of the old home, and the other applicable costs described above. In no case will the total CDBG assistance exceed \$40,000.

If the title search reveals additional owners other than occupants of the property, the applicant may take actions to obtain title from the other owners. If this occurs in a timely manner and sufficient funds remain to provide assistance, the application may be reconsidered for approval.

The County may approve assistance for owner-occupants who have a life estate in their home. In such cases, the owners must execute the deferred payment loan along with the occupying life estate holder. Only the life estate holder would be considered the owner-occupant, so if that individual(s) did not maintain owner-occupancy due to death or non-residence, the loan amount would become due according to the terms of the loan.

In addition to providing information relating to income eligibility and ownership, the applicant must also provide proof of insurance on the dwelling. If the owner cannot obtain a homeowner fire and casualty insurance policy due to the poor condition of the dwelling, the owner must provide a deposit on an insurance policy that is to be issued contingent upon the construction being performed. The deposit

must be an amount equal to six months of coverage for not less than the CDBG financing amount, plus any prior debt against the property. The homeowner must also obtain flood insurance for the complete after-rehabilitation or new construction value of the home if the home is located in a 100-year floodplain. The homeowner and flood insurance must be maintained by the owner for the full term of the CDBG deferred payment loan. The owner must be able to show the ability to pay for insurance, as well as other applicable housing expenses, in order to be approved for CDBG housing assistance.

Selection of homeowner applicants to assist may initially be on a first application completed and approved, first served basis. However, the administrator will review approved and potential rehabilitation and replacement cases to verify that the total number of housing units contracted in the CDBG grant agreement will be achieved, as well as the committed percentage/number of very low and low income homeowners and the contracted amount of leveraged local funds (SHIP or other). The application approval process must achieve the results contracted in the CDBG grant award, within the available grant period. This achievement will govern the application approval process. The Administrator will submit the list of qualified applicants to the Board of County Commissioners for approval prior to requesting bids.

If there are more eligible applications than can be approved through the first completed, first served approval process (within the above requirements), the administrator will rank the applicants according to a priority system. Priority will be given to applicants who have not received more than \$5,000 in housing assistance within the past five years, or \$10,000 within the past ten years, from the County or other government program such as weatherization, excluding loans requiring repayment. Within that group of applicants, and/or to rank the second tier of applicants, a scoring system may be used. One point will be assigned for each factor applicable to the owner and permanent residents of the home: a. owner(s) aged 65 or older, b. owner completely disabled, c. completely disabled dependent residing in the home.


