

The Lafayette County Commission held a budget workshop for the 2017-2018 fiscal year. The following Constitutional Officers and Department Heads made presentations to the board:



Scott Sadler – Lafayette County Public Works Director

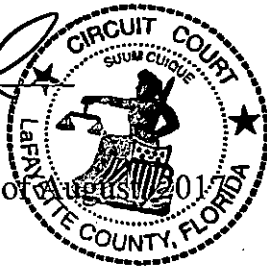
**ADJOURN**





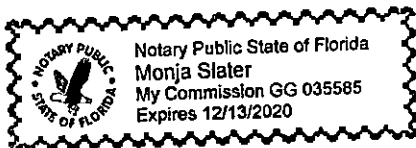
