#### **APPROVE THE MINUTES**

On a motion by Mrs. Garrard and a second by Mr. Byrd, the Board voted unanimously to approve the minutes.

#### **EXTENSION OFFICE SECRETARY RESIGNATION LETTER**

Mrs. Jana Hart discussed the Extension Office Secretary's letter of resignation. On a motion by Mrs. Garrard and a second by Mr. Hamlin, the Board voted unanimously to accept the resignation of Erica Maurer and to advertise for a replacement.

#### **TRAVIS SULLIVAN – COMPLAINT WITH EMS**

Mr. Travis Sullivan discussed a letter of reprimand concerning an EMS employee. A heated discussion took place between several citizens, some Board members, and Trevor Hicks concerning EMS. No formal action was taken by the Board. The reprimand in question was filed with the Clerk of Court after the meeting.

#### **REPAIRS TO BACKHOE FOR THE ROAD DEPARTMENT**

On a motion by Mrs. Garrard and a second by Mr. Hamlin, the Board voted unanimously to approve repairs to be done on the Backhoe at the Road Department. Mr. Scott Sadler obtained a quote in the amount of \$5,148.00 from Ring Power.

#### **BOBBY JOHNSON – VARIOUS ITEMS**

permits not be issued to citizens who have past due special assessments within the city limits. This would be consistent with the county policy.
