### REIMBURSEMENT FOR INDUSTRIAL PARK CLEAN-UP

### **ROAD & BRIDGE FUND**

Cost savings Summary

Ricky,

CRA has evaluated the cost savings of self performed work by Lafayette County Maintenance, Marcus Calhoun in regards to EOC and Industrial Park project as of today's date.

Currently, the county secured a proposal approximately 8 months ago from Dothan Steel Erectors to demo and correct steel issues as a result from the fire at that parcel. This proposal was was 103,000.00. The cost of material corrections for several beams at that time was 12,000.00. Thus, the value of labor and welding etc. which was performed by County Staff is \$91,000.00. The general cleanup at this site was valued at 25,000.00. So, the county has utilized staff to save on contract encumbered monies about \$ 116,000.00. At the EOC, the county self performed the building pad which had a cost of approximately \$ 18,000.00.

This is a very close summary of the values of work not contracted out and performed by county staff, Marcus Calhoun.
