Mr. Adams opened the Public Hearing and thanked everyone for attending. He then introduced Frank Darabi, county engineer, to give a presentation on the County's plans for the project. Mr. Darabi discussed the flooding in 2014 and provided some pictures from the County Road 300 area during the worst of the flooding. He then discussed the funding for the project, listing the Florida Legislature, Suwannee River Water Management District and Lafayette County Board of County Commissioners as the primary funding agencies. Mr. Darabi explained that some retention ponds will be built on both sides of County Road 300, that will be connected by a pipe or a ditch to try to eliminate some flooding. He stated that a v-notch system will be installed to release the water on a gradual basis. Calvin Stubbs, Iris Townsend, Debbie Durns, Joe Durns, Yvonne Giles, Emory Giles and Sampson Edwards provided questions about the project. Mr. Darabi answered all of their questions and everyone agreed that the project will improve the flooding issues in the area. Mr. Adams provided some closing statements and the hearing was adjourned.


