The Lafayette County Commission met on the above date and hour for a regular scheduled meeting. The meeting was held in the County Commissioner's meeting room in Mayo, Florida. The following members were present: Commissioner Lance Lamb, Dist. 1; Commissioner Thomas E. Pridgeon, Jr., Dist. 2; Commissioner Donnie Hamlin, Dist. 3; Commissioner Anthony Adams, Dist. 4; Commissioner Earnest L. Jones, Dist. 5; and Leenette McMillan-Fredriksson, County Attorney.

APPROVE THE MINUTES

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve the minutes.

SUWANNEE VALLEY ELECTRIC CHECK PRESENTATION

Mr. Baynard Ward, with Suwannee Valley Electric Cooperative, Inc., presented the Board with a check for property taxes in the amount of \$133,944.66.

OPEN BIDS FOR MOTOR GRADERS

The Board received bids from the following vendors for 2 motor graders: Ring Power and Beard Equipment Company. (See attached bid sheets.) On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to table awarding the bid until a special meeting that will be held on Wednesday, February 24, 2016 at 12:00 p.m. for the Board to further review the bids.

REQUEST TO WAIVE PERMIT FEE FOR THE FORESTRY SERVICE

On a motion by Mr. Jones and a second by Mr. Lamb, the Board voted unanimously to approve waiving the permit fee for a remodeling job at the Forestry Service building.

REQUEST FOR EXEMPTION FOR PAST DUE SPECIAL ASSESSMENTS

Mr. Bobby Johnson discussed with the Board a request from David Williamson to be exempt from paying his special assessments so that he can obtain a permit for his service pole. On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve allowing him to be put on the 2 year payment plan, which includes a 25% down payment.

LOCATION OF VOLUNTEER FIRE DEPARTMENT IN FIRST DISTRICT

The Board discussed the options of a location for the Volunteer Fire Department in the First District with Marc Land, Marty Tompkins and Sheriff Brian Lamb. The discussion was having the Fire Department located in Buckville vs. the Day location. No action was taken on this issue at this time.

OPEN SEALED BIDS FOR COUNTY SURPLUS PROPERTY

The Board opened sealed bids for various county surplus property that was previously advertised. One bid was received from Jeffords Miller in the amount of \$5,221.00 for the lot located in the Town of Mayo, known as the Old Cold Storage lot. On a motion by Mr. Pridgeon and a second by Mr. Adams, the Board voted unanimously to award the bid to Mr. Miller.

CRAWFORD STREET RESURFACING PROJECT

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve task order 2016-02 for Preble-Rish, Inc. to complete the CEI work for the Crawford Street resurfacing project.

On a motion by Mr. Pridgeon and a second by Mr. Adams, the Board voted unanimously to approve Preble-Rish, Inc. taking over the Crawford Street resurfacing project from Darabi and Associates upon the finalization of the plans and to advertise it. The advertisement should include an addendum for the School Board and Sheriff's parking, as well as, a price for 1.1 miles in Northwood Acres subdivision.

COUNTY ROAD 416 PROJECT

On a motion by Mr. Adams and a second by Mr. Jones, the Board voted unanimously to approve a change order request in the amount of \$6,952.66, for the County Road 416 project for Preble-Rish, Inc (see attached).


