## REGULAR MEETING JUNE 27, 2016 5:30 P.M.

The Lafayette County Commission met on the above date and hour for a regular scheduled meeting. The meeting was held in the County Commissioner's meeting room in Mayo, Florida. The following members were present: Commissioner Lance Lamb, Dist. 1; Commissioner Thomas E. Pridgeon, Jr., Dist. 2; Commissioner Donnie Hamlin, Dist. 3; Commissioner Earnest L. Jones, Dist. 5; and Leenette McMillan-Fredriksson, County Attorney.

#### APPROVE THE MINUTES

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve the minutes.

#### LAFAYETTE ACTIVITIES GROUP

Kelli Joyner and Tresa Jackson had a request from some individuals who want to sell concessions at the 4<sup>th</sup> of July festivities. After discussion by the Board, on a motion by Mr. Jones and a second by Mr. Lamb, the Board voted unanimously to approve their request, and to have these requests approved on a case by case basis should anyone want to do this in the future.

There also was a request for the Lafayette Activities Group to use the Chamber of Commerce building for office space if the Chamber isn't currently using the space. Mr. Lamb said that the Board would have Mrs. McMillan-Fredriksson contact Vi Johnson, one of the members of the Chamber of Commerce, to see if the space could be used by the Lafayette Activities Group.

#### LAFAYETTE COUNTY INDUSTRIAL PARK

Marcus Calhoun, Lafayette County Maintenance, discussed a request from Animal Health to cool 1,500 sq. ft. of space that they have for storing their medicine. The total cost of the job is estimated around \$19,930.00. Animal Health has already gotten the funds approved for the job from their corporate office. The Board wants Marcus to do the work on this job, and he said that he estimated that it will take him around a month to complete. The Board asked Marcus to discuss the details further with Animal Health and report back to them.

#### LAFAYETTE COUNTY ROAD DEPARTMENT

Scott Sadler, Lafayette County Public Works Director, wants to purchase a side discharge bucket that attaches to Road Department equipment for clean-up work. On a motion by Mr. Pridgeon and a second by Mr. Lamb, the Board voted unanimously to advertise for bids.

#### UNUSED COUNTY PARCELS

On a motion by Mr. Jones and a second by Mr. Pridgeon, the Board voted unanimously to table this issue, and to hold a workshop at a later date to further discuss this.

#### PUBLIC HEARING – DISCUSS ROAD NAMES FOR 911 PURPOSES

The Board held a public hearing to discuss road names in the McCall's Chapel, Lafayette Loop and SE Meadowlark Lake area for 911 purposes. On a motion by Mr. Pridgeon and a second by Mr. Jones, the Board voted unanimously to amend Ordinance 99-1 and to have Mrs. McMillan-Fredriksson prepare and Ordinance that reflects those changes.

#### **BUILDING OFFICIAL JOB DESCRIPTION**

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve the Building Official job description. On a motion by Mr. Pridgeon and a second by Mr. Jones, the Board voted unanimously to advertise the job description to receive applications.

#### DOT RESOLUTION

On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to have Mrs. McMillan-Fredriksson read Resolution No. 2016-06-02-01 by title only. On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to approve the resolution for the Department of Transportation's Safety Intersection Implementation Plan.

#### OPEN SEALED BIDS FOR HURST BOAT RAMP RECONSTRUCTION

The Board opened sealed bids for reconstruction of the Hurst Boat Ramp. The following bids were received: Construction Company, Inc. – bid amount \$125,819.00; and Live Oak Management Group – bid amount \$138,500.00. On a motion by Mr. Pridgeon and a second by

Mr. Jones, the Board voted unanimously to approve the low bid pending Brenda Flanagan, with Preble Rish, reviewing and both bids and giving the Board her approval.
