APPROVE THE MINUTES

On a motion by Mr. Jones and a second by Mr. Pridgeon, the Board voted unanimously to approve the minutes.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to approve an indigent burial request for Joyce Peterson.


APPROVE THE BILLS

- Industrial Park Fund - \$569.78


ADJOURN

On a motion by Mr. Adams and a second by Mr. Jones, the Board voted unanimously to adjourn.

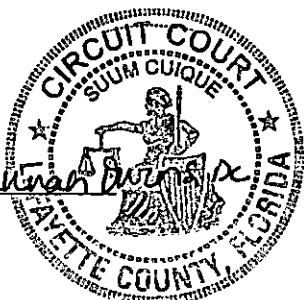
