The Lafayette County Commission met on the above date and hour for a regular scheduled meeting. The meeting was held in the County Commissioner's meeting room in Mayo, Florida. The following members were present: Commissioner Lance Lamb, Dist. 1; Commissioner Thomas E. Pridgeon, Jr., Dist. 2; Commissioner Lisa Walker, Dist. 3; Commissioner Anthony Adams, Dist. 4; Commissioner Earnest L. Jones, Dist. 5; and Leenette McMillan-Fredriksson, County Attorney.

APPROVE THE MINUTES

On a motion by Mr. Pridgeon and a second by Mr. Adams, the Board voted unanimously to approve the minutes.

KERRY WALDRON WITH FLORIDA DEPARTMENT OF HEALTH

Mr. Kerry Waldron with the Florida Department of Health invited the Board to their open house to see the renovations that have been done to the Mayo Health Department on Thursday, December 15, 2016. No action was taken on this issue.

JOHN PAT THOMAS PRESENTATION TO THE BOARD

Mr. John Pat Thomas, with Florida Municipal Insurance Trust, presented the Board with a refund check in the amount of \$7,899.00. No action was taken on this issue, presentation only.

DAY COMMUNITY CENTER FLOORS

Marcus Calhoun discussed the floors at the Day Community Center with the Board. The Board agreed to advertise to receive bids to redo the flooring at the community center.

COURTHOUSE PLUMBING SYSTEM

Marcus Calhoun discussed the problems with the plumbing at the Courthouse. Marcus got a quote from Roundman's Pump Repair and Well Drilling in the amount of \$4,300.00. On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to have Marcus get three quotes to replace the well at the Courthouse before proceeding with the work. Mr. Adams suggested wanting to view a cost estimate for city water at the Library and see what it would cost for the Courthouse to go on city water. The Board wants to review these figures before making a final decision on what to do with the plumbing system.

COURTHOUSE CUSTODIAN

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to accept the resignation letter of Paris Edwards, as the Courthouse and Extension Office custodian. On a motion by Mr. Pridgeon and a second by Mr. Lamb, the Board voted unanimously to advertise for a new Courthouse and Extension Office custodian, and to also allow Tina Finch, Mayo Community Center Custodian, to fill in until someone is hired at the same rate of pay that Paris received.

COLLECTION SITE ATTENDANT POSITION

On a motion by Mr. Pridgeon and a second by Mr. Adams, the Board voted unanimously to approve Public Works Director's recommendation to hire Shirley Lawson and James Lawson to fill the part time collection site attendant position on an as needed basis.

SOLICITATION OF STATE FUNDS POLICY

On a motion by Mr. Adams and a second by Mr. Lamb, the Board voted unanimously to approve the policy drafted by Mrs. McMillan-Fredriksson in regards to the solicitation of state funds.

APPROVE THE BILLS

On a motion by Mr. Adams and a second by Mr. Pridgeon, the Board voted unanimously to approve the following bills:

Emergency 911 Fund - \$1,744.91
Industrial Park Fund - \$8,359.06


