Thanks for meeting us at the Picket Lake Bridge to discuss the project. In summary, these are the options we spoke about during our meeting at the bridge.

The department currently has two projects programmed for the Island Drive/Picket Lake Bridge. The first project is a SCOP project for rehabilitation for \$300,000 in FY 2019 (438174-1). The second project is to replace the bridge under the Federal Aid Off-System Bridge Replacement Program for \$2.9 million in FY 2021 (437425-1). Neither the Department nor County want to expend funds on the bridge rehabilitation project only to replace the bridge shortly thereafter.

The meeting was held on-site at the bridge on 3/28/2017 and several alternatives were discussed. It is the Departments understanding that the County does not want to pursue the Federal Aid Bridge Replacement project in FY 2021. Below is a summary of the alternatives discussed in lieu of the bridge replacement and the department needs to know which of these alternatives the County prefers:

- - Alternative 1: Proceed with the currently funded rehab project for \$300,000 in FY 2019. The County will be responsible for any expenses over the \$300,000 programmed;
 - Alternative 1A: Same as #1 above except advance the project into FY 2018. The County can proceed with the project in FY 2018 but will not be reimbursed until FY 2019;
 - Alternative 2: Defer the project to FY 2020 and increase the funding to \$500,000. The County will be responsible for any expenses over \$500,000;
 - Alternative 2A: Same as #2 above except advance the project to FY 2019. The County can proceed with the project in FY 2019 but will not be reimbursed until FY 2020.

A few items to note regarding these alternatives:

- The \$500,000 is a figure discussed during the meeting on 3/28. If the County believes the \$500,000 is not sufficient to rehab the bridge, the County needs to provide an estimate of how much funding is needed;
- The County must secure the right of way before any construction can begin to rehab the bridge. The Department will not participate in any of the right of way acquisition;
- If the County selects alternative 2 or 2A, the \$300,000 in FY 2019 will stay with the Department and will not be reallocated to another project within the County;
- The amounts identified include all costs such as the design, construction and CEI.

The Department is requesting either a resolution or letter from the Board of County Commissioners confirming their desire to delete the Federal Bridge Replacement project, and which alternative the County prefers for the rehabilitation of the bridge.
