Energy Efficiency and Conservation Block Grant, approved for \$250,000.

It will provide various energy upgrades at the community centers (see attached Project Description page). County match is \$32,079 (in-kind salaries and benefits of county employees who will work on the project). This grant will require Davis-Bacon Act compliance and very extensive reporting of jobs and other things, so 10% is allowed in the grant. Will need to advertise for admin services to be paid by grant.

FRDAP (Florida Recreation Development Assistance Program) Grant

Only \$300,000 was allocated statewide for FRDAP grants in the current year, so Lafayette County's application was not awarded. New FRDAP grants will be accepted this year (usually in September or October). Applicants must submit new applications; old applications will not be rolled over into the coming year and it is likely some of the criteria will be changed. When the time comes, RPDS would be willing to update and resubmit the previously submitted application at no charge for our services. That application was titled "Lafayette County Fourth District Community Center Enhancement."

FBIP Grant

The Florida Boating Improvement Program rule is being amended to allow federal funds to be used. The funding cycle hasn't been set, but applications might be due in July-August, 2010. This will be especially competitive due to lack of state funding.

CDBG Grant Application

The County can apply for another \$700,000 grant, with applications possibly due July 12, 2010. RPDS is developing a list of interested homeowners who might qualify for housing rehabilitation or replacement. Recommend putting some weatherization and/or other funds with the CDBG grant for leverage points, if possible.

Debbie Belcher helped the County do the first public hearing and fair housing session in September 2009. The County decided to apply for another Housing CDBG. Following is a schedule for completing the grant application by July 12, 2010. This schedule sets the second public hearing for June 14, 2010, which avoids any last-minute problems.

Six county buildings have been selected for envelope and/or equipment upgrades as part of this project. Four of these buildings will receive new HVAC units. According to the SEP Metric, four HVAC units result in 1234 million source BTUs saved, 21 metric tons of carbon reduction, 79 MWh saved, and 340,000 cubic feet of natural gas saved. The buildings taken together constitute approximately 23,414 SF of heated and cooled space to be retrofitted as described. According to the metric, this will result in 1140 million source BTUs saved, 20 metric tons of carbon reduction, 93 MWh saved, and 116,000 cubic feet of natural gas saved. Here are the proposed retrofits by building:

- The County Extension Agency Classroom building at 176 SW Community Circle, Mayo. Retrofits include double-paned low-E windows, energy rated exterior doors, Energy Star roof covering, siding to reduce solar heat gain and air infiltration, low-energy interior lighting with motionactivated controls, and high-efficiency (14 SEER minimum) HVAC system with reverse cycle heat pump.
- The Barrington Office Complex/5th District Community Center, located on Highway 27 (Main Street) on the western outskirts of Mayo. Retrofits include double-paned low-E windows, energy rated exterior doors, low-energy interior lighting with motion-activated controls, tankless LP water heater, and insulation for hot water supply lines.
- The 2nd District Community Center. Retrofits include double-paned low-E windows, energy rated exterior doors, Energy Star roof covering, low-energy interior lighting with motion-activated controls, tankless LP water heater with insulation for hot water supply lines, and insulation for the exterior walls and floors.
- The 3rd District Community Center, at the intersection of County Road 354 and US Highway 27 4.8 miles east of Mayo. Retrofits include double-paned low-E windows, energy rated exterior doors, low-energy interior lighting with motion-activated controls, high-efficiency (14 SEER minimum) HVAC system with reverse cycle heat pump, tankless LP water heater with insulation for hot water supply lines, and insulation for the exterior walls and floors.
- The 4th District Community Center, on US Hwy 27 15.4 miles south (or southeast) of Mayo. Retrofits include double-paned low-E windows, energy rated exterior doors, low-energy interior lighting with motion-activated controls, high-efficiency (14 SEER minimum) HVAC system with reverse cycle heat pump, tankless LP water heater with insulation for hot water supply lines, and insulation for the exterior walls and floors.
- The Day Community Center in the town of Day, 1st District. Retrofits include double-paned low-E windows, energy rated exterior doors, low-energy interior lighting with motion-activated controls, high-efficiency (14 SEER minimum) HVAC system with reverse cycle heat pump, tankless LP water heater with insulation for hot water supply lines, and insulation for the exterior walls.

The County Day Camp Program, administered by County Extension Agent Ms. Jana Hart, serves an average of 20 local children over the course of the summer. During this program, grant funds will be used to introduce of blocks of energy awareness and conservation education to the students. The education will include weekly field trips, to include a trip to visit the University of Florida's Rinker Hall, the first LEED gold-certified building in the state of Florida. At other times the programs will include guest lectures and demonstrations and field trips to more local facilities to help students understand how energy and environment are affected by actions in their own community. According to the SEP Metric, the education of 20 students results in savings of 22 million source BTUs, 1 MWh, and 5,000 cubic feet of natural gas.

The metric calculates total monetary savings for the entire grant of \$13,452 annually.

Re: Relocation of 911 Dispatch for Lafayette County Jail

Dear Ricky:

On March 15, 2010 at 9:00 a.m., we met with Sheriff Brian Lamb and yourself to discuss the 911 Dispatch relocation of the County Jail. Currently, the County Jail 911 Dispatch is located in the Central Control Room which is crowded and does not work efficiently to accommodate present day use of jail inmates and jail operations. A discussion and review of this facility was performed on the above date to find an adequate location for relocating 911 Dispatch.

Current standards throughout the corrections industry is to move 911 Dispatch centers out of jail Operation Control Rooms due to the hectic schedules and more repeated calls associated with 911 centers. It is highly recommended to not locate 911 centers within the Dispatch areas of current operational jails due to personnel and increased use by citizens.

In reviewing the current jail and courthouse situations, it is my recommendation that the Chief Jailer be relocated to an office which is currently occupied by the EMS Coordinator. That would free the Jail Administration Office which has a bathroom adjacent to it. Therefore, the best plan solution for the size available and the least cost appears to be to move the 911 Dispatch into the Jail Administrator's current office, seal the door off to the corridor, install the door from the Dispatch into the women's toilet room and making it a unisex women/men's restroom for 911 and then converting the men's toilet to a unisex restroom to handle the public for the rest of the facility.

These changes would need to be reviewed with local building officials to be certain there are no issues or concerns that they have with these changes. At this point, the current EMS Coordinator would relocate to the County Courthouse adjacent to the public Safety Director's Office which is in the northeast corner of the Courthouse on the second floor. This change would condense and solidify

their work and efforts together, as they work in the same department and same areas of expertise. This would relocate all other operations that are not currently jail oriented out of the County Jail and would free up the Operations Room for conferencing, tactical training if needed and remain as an EMS secondary location for catastrophic event use.

In summary, the least destructive measure seems to be to relocate 911 to the current Jail Administrator's Office, add a door to the restroom giving them full access to a restroom for duties of 911 Dispatch, relocating the Chief Jailer to the EMS Coordinator's Office and relocating the EMS Coordinator to the County Courthouse adjacent to the Supervisor of Public Safety Director's Office.

On Wednesday, April 28,2010 the following people met to discuss the the 9-1-1 Dispatch and the Emergency Operations Center : Donnie Hamlin, Board Chairman, Brian Lamb , Sheriff, Ricky Lyons Clerk, Donnie Land, Public safety, and Alton Scott , Emergency Management.

The grant for Jail Management and 9-1-1 Dispatch that has been received by the Sheriff was discussed. The idea of moving Dispatch to the EOC Building was discussed. This will enable the county to fully implement the new system and comply with the coming new laws in regards to Emergency Dispatch. The ability to do this has been helped by Mayo Medical Inc's plans to build a new facility. The new building will set off a chain of events that could assist the county by enabling the Health Department to complete their move out of the old Dental Clinic Building. The old Dental Building could be used for The Emergency Operations Center and in the distant future when space is needed at the Courthouse for Building and Zoning. Public Works already uses part of the building.

Emergency Operations would need a "safe room" built if they moved to the old Dental Clinic Building. This is needed at the present time because the existing EOC Building doesn't meet the minimum wind standards .A grant will be pursued for this. In the interim the Emergency Management Coordinator could be housed adjacent to Public Safety on the second floor of the Courthouse.

The funding for the needed changes was discussed. There is available funding in the Infrastructure surtax fund for the projects. This fund can only be used for long term projects.

The outdated radio system that the county has was discussed. There are new Federal Requirements that are going to have to be met by 2012. There are 2-3 alternatives to fixing this problem. It was discussed to get some proposals for the Board to consider in the next few months.

The suggested time line for the above events is as follows:

May10, 2010- Present to County Commission for their approval.

June 2010- Presentations to the Board on updating the radio system

Summer 2010- Review existing lay-out of EOC and decide how to change for 911 Dispatch

Fall of 2010- Move EOC Coordinator to Courthouse temporarily

Fall of 2010- Make changes to EOC using county maintenance and Inmate labor

2011- Make necessary changes to Radio system

Fall of 2011- Make changes to old Dental Clinic Building to house EOC. (To be done after the Health Department moves out)


