### **ROAD DEPARTMENT EMPLOYEE RAISE**


On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to approve giving Michael Frier his 15 year raise.

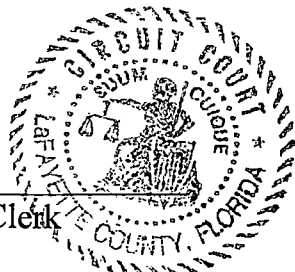
### **ADJOURN**
