

The annual reorganization meeting of the Lafayette County Commission was held on November 28, 2011 at 5:00 p.m. with the following members present: Mr. Lance Lamb – Dist. 1; Mrs. Gail Garrard – Dist. 2; Mr. Donnie Hamlin – Dist. 3; and Mr. Earnest L. Jones – Dist. 5.

The meeting was called to order by Ricky Lyons, Clerk of Court. The floor was opened for nominations for Chairman. Mr. Hamlin nominated Mr. Jones for Chairman. On a motion by Mr. Hamlin and a second by Mrs. Garrard, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Jones as Chairman. Mr. Jones assumed the duties of the Chair. The floor was opened for nominations for Vice-Chairman. Mr. Hamlin nominated Mr. Lamb. On a motion by Mr. Hamlin and a second by Mrs. Garrard, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Lamb as Vice-Chairman.

On a motion by Mr. Hamlin and a second by Mrs. Garrard, the board voted unanimously to re-hire Scott Sadler as Public Works Director.

On a motion by Mr. Lamb and a second by Mr. Hamlin, the Board voted unanimously to re-hire Bobby Johnson as Building/Zoning Official.

On a motion by Mr. Hamlin and a second by Mr. Lamb, the Board voted unanimously to re-hire Donnie Land as Industrial Park/Public Safety Director.

On a motion by Mrs. Garrard and a second by Mr. Hamlin, the Board voted unanimously to re-hire Marcus Calhoun as County Maintenance worker.

On a motion by Mr. Hamlin and a second by Mrs. Garrard, the Board voted unanimously to re-hire Alton Scott as Emergency Management Coordinator. On a motion by Mr. Hamlin and a second by Mr. Lamb, per the request of Donnie Land, the Board voted unanimously to change Donnie Land's title to Coordinator and Alton Scott's title to Director (in reference to Emergency Management).

The Board voted the following way on re-hiring Trevor Hicks as EMS Coordinator: Lance Lamb – No, Gail Garrard – Yes, Donnie Hamlin – Yes, Earnest Jones – No. With there not being a majority vote on a motion by Mr. Hamlin and a second by Mrs. Garrard, the Board voted unanimously to postpone this issue until the next regular meeting on December 12, 2011. Mr. Hicks will continue as EMS Coordinator until further notice.

On a motion by Mr. Lamb and a second by Mr. Hamlin, the Board voted unanimously to advertise for the position of EMS Medical Director. This position is currently held by Dr. Robert Spindell, and he will continue to hold this position until it is filled.

On a motion by Mr. Hamlin and a second by Mr. Lamb, the Board voted unanimously to re-hire Cindy Tysall as County Librarian.

On a motion by Mr. Lamb and a second by Mrs. Garrard, the Board voted unanimously to re-hire all of the County custodians as follows: Julie Mortlock – Day Community Center; Robert & Margaret Cannady – Mayo Community Center; Lori Fredriksson – Airline Community Center; Bonnie Adams – Fourth District Community Center; and Paris Edwards – Courthouse and Extension Office.

On a motion by Mr. Lamb and a second by Mr. Hamlin, the Board voted unanimously to re-hire the County Attorney, Leenette McMillan-Fredriksson.

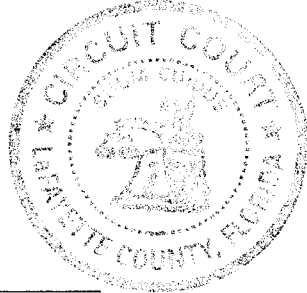

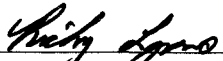
On a motion by Mrs. Garrard and a second by Mr. Hamlin, the board voted unanimously to adjourn.
