The annual reorganization meeting of the Lafayette County Board of County Commissioners was held on November 22, 2016 at 9:00 a.m. with the following members present: Mr. Lance Lamb – Dist. 1; Mr. Thomas E. Pridgeon, Jr. – Dist. 2; Mrs. Lisa Walker – Dist. 3; Mr. Anthony Adams – Dist. 4; and Mr. Earnest L. Jones – Dist. 5.

The meeting was called to order by Steve Land, Clerk of Court. The floor was opened for nominations for Chairman. Mr. Lamb nominated Mr. Jones for Chairman and Mr. Pridgeon seconded the motion. On a motion by Mr. Adams and a second by Mr. Pridgeon, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Jones as Chairman. The floor was opened for nominations for Vice-Chairman. Mr. Lamb nominated Mr. Adams and Mr. Pridgeon seconded the motion. On a motion by Mr. Pridgeon and a second by Mr. Lamb, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Adams as Vice-Chairman.

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to appoint Mr. Anthony Adams to the North Florida Regional Planning Council Board.

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to appoint Mr. Lance Lamb to the Economic Development Board.

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to appoint Mr. Anthony Adams and Mr. Earnest Jones as the Lafayette County representatives to the Small County Coalition Board.

On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to re-hire all Department Heads, with the exception of Bobby Johnson, Building Official due to his upcoming retirement. On a motion by Mr. Adams and a second by Mr. Lamb, the Board voted unanimously to re-hire Bobby Johnson pending his retirement, effective January 3, 2017.

On a motion by Mr. Pridgeon and a second by Mr. Lamb, the Board voted unanimously to re-hire all Community Center custodians.

On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to re-hire all positions under the Department Heads.

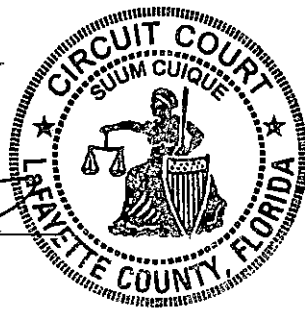
On a motion by Mr. Adams and a second by Mr. Lamb, the Board voted unanimously to remove County Road Engineer out of the Professional Services re-hire listing and vote on it separately. On a motion by Mr. Pridgeon and a second by Mr. Lamb, the Board voted unanimously to re-hire the following Professional Services for Lafayette County: Leenette McMillan-Fredriksson – County Attorney; Darabi and Associates, Inc. – Solid Waste Engineer; Clemons Rutherford, Inc. – Construction and Project Architect and Engineer; Jim Davis, CPA – County Auditor; and Robert Spindell, M.D. – EMS Medical Director. On a motion by Mr. Lamb and a second by Mr. Pridgeon, the Board voted unanimously to approve re-hiring Darabi and Associates, Inc. as County Roads Engineer. On a motion by Mr. Adams and a second by Pridgeon, the Board voted unanimously to approve re-hiring Dewberry Engineers, Inc. as the CEI Engineering Firm.


