- 2. At least one (1) year has passed since you last elected to attend a Driver Improvement Course.

## PENALTY FOR FALSE AFFIDAVIT:

Should the State find you did not meet the above stated eligibility requirement to elect the Driver Improvement Course option, your Driver License may be suspended, points will be assessed, and substantial fines and fees will be imposed.

IN CHOOSING THE DRIVER IMPROVEMENT COURSE, THE FOLLOWING APPLY:

- 1. Pay fine within 30 days to: LAFAYETTE COUNTY CLERK OF COURT, PO BOX 88 MAYO FL 32066 along with your affidavit
- 2. Driver Improvement Course must be completed and proof of completion returned to clerks office within 60 days from the election date of school.

## PENALTIES FOR FAILURE TO COMPLETE COURSE AND/OR PAY COST AND FEE BY DEADLINE

- 1. Your Driver's License will be suspended, and points will be assessed pursuant to Florida Law, before your license can be reinstated, you must:
  - A. Pay the balance of the original fine
  - B. Pay a \$18.00 cancellation-processing fee.
  - C. Pay a \$23.00 late fee.
  - D. Pay a \$60.00 reinstatement fee.
